Public Participation:

The Approval Authority will take public comment on an action item before the Approval Authority takes any action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to that particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- General Public Comment. The Approval Authority shall include public comment as an agenda item at each meeting of the Approval Authority. During public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during public comment, for up to three minutes. The Chair may limit the total public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during public comment and the number and anticipated duration of agenda items.
- *Speaker Identification.* Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.
- Designated Public Comment Area. Members of the public wishing to address the Approval Authority must speak from the public comment area.
- Comment, Not Debate. During public comment, speakers shall address their remarks to the Approval Authority as a whole and not to individual Approval Authority representatives, the General Manager or Management Team members, or the audience. Approval Authority Representatives and other persons are not required to respond to questions from a speaker. Approval Authority Representatives shall not enter into debate or discussion with speakers during public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.
- Speaker Conduct. The Approval Authority will not tolerate disruptive conduct by individuals making public comment. Speakers who use profanity or engage in yelling, screaming, or other disruptive behavior will be directed to cease that conduct and may be asked to leave the meeting room.

REGULAR MEETING MINUTES DRAFT

1. ROLL CALL

Approval Authority Chair Mary Ellen Carroll called the meeting to order at 10:03 AM and General Manager Craig Dziedzic subsequently took the roll. Chair Mary Ellen Carroll and Vice Chair Rich Lucia were present. Members Erica Arteseros, Jessica Feil, Raymond Riordan, Dana Reed, Gerry Malais, and Mark Robbins were present. Members Mike Casten, Bob Doyle, and Chris Godley were absent, but their alternates Ryan Borkert, Craig Scardino, and Jeff Duvall were present.

2. APPROVAL OF THE MINUTES

Chair Carroll asked for any comments or questions concerning the minutes from the September 9, 2021 meeting. She then called for public comment.

One member of the public made a comment.

Chair Carroll then requested a motion to approve the minutes.

3. GENERAL MANAGER'S REPORT

(a) Notification of Subrecipient Award FY 2021

General Manager Craig Dziedzic informed the Approval Authority of Cal OES' approval of the Bay Area UASI's FY 2021 Homeland Security Grant Program application for \$30,562,500. A conditional hold was placed on one of cybersecurity project and three projects involving domestic violent extremism. The Management Team is coordinating with Cal OES and FEMA to provide additional information to release the hold. The Management Team is awaiting the Grant Assurances and will be sending all the FY2021 MOUs to grant sub-recipients who may begin incurring expenses after these MOUs are executed and returned.

(b) FY 2021 Targeted Violence and Terrorism Prevention (TVTP) Grant Program

General Manager Dziedzic reported that the Bay Area UASI received notice in late September that it was one of several recipients of FY 2021 TVTP grant program funding. The award, in the amount of \$1,060,942, was the second largest award. Only the University of Colorado received more funding.

(c) UASI FY2022/FY2023 Project Proposal Process

General Manager Dziedzic reported on the online FY2022/23 project proposal submission process for FY 22/23. The Management Team received more than 200 applications and funding requests exceeded available for funding for both grant years by more than \$2.2 million dollars. Hub Voting Members have performed their initial review and the projects are currently under review by the Management Team. Next, Approval Authority members will have an opportunity to review all projects prior to the Hub regional prioritization meetings in January.

(d) Approval of the 2022 Calendar for Approval Authority Meetings

This action item seeks approval of the 2022 calendar of Approval Authority meetings. The meetings are scheduled for January, March, June, September, and November.

(e) Approval of the Revised 2021 Master MOU

This action item seeks approval for the revised Master MOU that was previously approved at the September 9th Approval Authority meeting. Due to concerns about one of the clauses, that clause was removed and now requires a vote to approve the revised Master MOU.

(f) Management Team Staff Update

GM Dziedzic provided an update on two changes within the Management Team staff. Corrine Bartshire has been promoted to the regional program manager position for the Bay Area Training and Exercise Program and Matthew Devine has joined the Bay Area UASI Management Team as the Training and Exercise Project Manager, overseeing the training course administration for the regionwide Bay Area Training and Exercise Program (BATEP). Matt served 28 years in the Santa Rosa Fire Department as a captain/paramedic, is a state-certified fire officer involved in numerous projects including training, policy development, and a technical committee member on NFPA 1600 Standard on Continuity, Emergency, and Crisis Management. In addition, Matt has worked with

schools throughout the Bay Area for the past 15 years as an emergency consultant focusing on risk analysis, training delivery, and digital planning.

(g) Management Team Tracking Tool and Future Agenda Items
General Manager Dziedzic reported on the Tracking tool and future agenda items, requesting that
Approval Authority members submit future agenda items at any time to him.

4. THIRA/SPR APPROVAL

Regional Project Manager Amy Ramirez presented the annual THIRA and SPR for approval as an action item due to the FEMA requirement that all Homeland Security Grant recipients submit these documents on an annual basis. She further explained that the THIRA is designed to assist communities understand risks and identify capabilities needed to address risks and threats while the SPR provides a framework to assess a community's capacity to address the threats and hazards identified in the THIRA.

Chair Carroll requested comments from the Approval Authority.

Member Arteseros posed a question regarding the THIRA dashboard

5. ABAHO/BAMPWG VACCINE POINT OF DISPENSING (V-POD) OPERATIONS PROJECT UPDATE (Discussion)

ABAHO Coordinator Emma Hunter presented an update on the ABAHO/BAMPWG Mass Vaccination Planning Project. She provided background information, indicating that the FY19 regional mass prophylaxis exercise had been cancelled due the COVID-19 pandemic. As a result, the project scope of work was revised in February 2021 to provide guidance to local jurisdictions to enhance interoperability and compatibility in setting up, managing, and operating vaccine points of dispensing. The resulting plans include a Vaccine Point of Dispensing Operational Plan (V-POD) and three Field Operations Guides to support walk-thru, drive-thru, and mobile vaccine dispensing. Virtual Train the Trainer training on the plans is scheduled for completion by the end of December.

Chair Carroll requested comments from the Approval Authority.

Member Reed inquired about the notification process for the Train the Trainer component and the answer was mid-level representatives from ABAHO were receiving this training. Member Malais inquired about training managers within the region.

6. GRANT FUNDED PROGRAMS UPDATE

BAUASI Program Managers presented updates on the region's grant-funded programs.

(a) BAY AREA TRAINING AND EXERCISE PROGRAM (BATEP) UPDATE
Regional Program Manager Corinne Bartshire presented an update on the BATEP. She indicated that 138 courses had been conducted for over 3800 attendees in 2021. In addition, 1800 new accounts have been created and the website has received more than 190,000 page views.

(b) SECURING THE CITIES SAN FRANCISCO BAY AREA (STC SFBA) UPDATE Regional program manager Dominic Yin presented an update on STC SFBA. He indicated that the program is in year three and they are currently awaiting approval of the Concept of Operations. Procurement of equipment is ongoing and various training classes are being conducted.

(c) TARGETED VIOLENCE AND TERRORISM PREVENTION (TVTP) PROGRAM UPDATE

Regional Program Manager Jodi Traversaro presented an update on the TVTP program. She indicated that funds for the FY 21 award will fund 4 new projects including cross-sector threat assessment training and toolkit, combatting on-line radicalization training, media literacy and critical thinking training, and a mental health student film contest. She also updated members on the FY 20 projects.

A member of the approval authority thanked Program Manager Jodi Traversaro for her work on the TVTP program and congratulated her on her success.

Member Malais Monterey member inquired about Jodi's progress in recruiting Monterey County schools into her programming and asked about how schools are recruited in general. (Reference audio here: November UASI Approval Authority Meeting Audio at 1:02:00)

(d) REGIONAL CATASTROPHIC PREPAREDNESS GRANT PROGRAM (RCPGP)

Regional Project Manager Amy Ramirez presented an update on RCPGP funding. She indicated that the FY 21 award has gotten underway. This award is designed to address supply chain issues. She also provided updates on the FY 20 and FY 19 awards.

Chair Carroll requested comments from the Approval Authority. Seeing none, she requested public comment.

One member of the public made a comment.

7. NCRIC THREAT BRIEFING

NCRIC Executive Director Mike Sena presented a briefing on Regional Information Sharing. The NCRIC examined the use of the regional deconfliction system – which allows agencies to enter information that is viewable by other law enforcement agencies – to prevent duplication of efforts and provide officer safety when multiple agencies arrive on-scene to an event. An assessment was conducted and discovered that only 36% of agencies are using the system. The NCRIC is reaching out to these agencies to better utilize the system.

Chair Carroll requested comments from the Approval Authority. Seeing none, she requested public comment.

One member of the public made a comment.

8. SUBRECIPIENT MONITORING AND DESK REVIEW RESULTS

CFO Tristan Levardo provide an update on the results of the desk review of FY19 BAUASI grant funds. Between June and October, the Grants Management Unit conducted desk reviews of18 jurisdictions. There were findings in procurement, inadequate internal controls, corrective actions, and program management. The fiscal team expects to resume in person monitoring in 2022.

Chair Carroll requested comments from the Approval Authority. Seeing none, she requested public comment.

One member of the public made a comment.

Discussion/Description:

(a) FY 2022 UASI Grant (Discussion Only)

On December 2, 2021, Congress passed a Continuing Resolution to provide funding for Federal government programs through February 18, 2022. In order to release the FY 2022 UASI Notice of Funding Opportunity (NOFO), Congress will need to pass legislation for appropriations of the entire 2022 fiscal year.

When reviewing both U.S. House and U.S. Senate Appropriation Bills for FY 2022, it is expected the UASI grant program will receive \$616 million in funding, which was the same level of funding as FY 2021 (\$705 million for the UASI Grant Program minus \$90 million for the Nonprofit Security Grant Program).

(b) 2022 National Homeland Security Conference (Discussion Only)

Cleveland, Ohio will host the 2022 National Homeland Security Conference from July 11 - July 14, 2022. All Approval Authority members and/or Alternates who are interested in attending the conference should contact the UASI Management Team and complete the Bay Area UASI Travel Request document.

A. Risk Management Program Overview (Discussion)

Background:

Each year the Bay Area UASI Risk Management Program includes data input, validation, assessments, and reporting to support decision-making and guide grant spending. A risk and capability-based methodology to allocate UASI funds is required by the Department of Homeland Security and is mandated in the Bay Area UASI Approval Authority Bylaws.

Discussion:

The Management Team has completed its planning for the 2022 risk management cycle in partnership with jurisdictions, the NCRIC, and Haystax. An overview of program highlights is summarized below and provided in a PowerPoint presentation (Appendix A).

Risk Management 2022 Program Highlights

- The UASI Management Team will hold a Risk Management kick-off webinar for stakeholders.
- Jurisdictions will conduct their annual asset review to fill information gaps and add Special Events for use in the Department of Homeland Security annual data calls.
- The NCRIC will update mass transit systems in Cal COP.
- Haystax will refresh the Population data input for the FY23 Hub Funding Formula using the most recent Census data.

THIRA / SPR 2022 Highlights

All Homeland Security fund grantees are required by DHS to produce a Threat Hazard Identifications and Risk Assessment (THIRA) and a Stakeholder Preparedness Review (SPR). FEMA requires a full review of the THIRA and the SPR assessment of all Capability Targets in 2022. The UASI Management Team will review the draft THIRA and SPR in October. The final THIRA and SPR will be presented for approval at the November Approval Authority meeting in preparation for submission to FEMA by December 31, 2022.

Risk Management Program Schedule

This year, there are four main steps to our risk management process:

1. Risk Management Kick-Off Meeting January 26, 2021, 9:00 am – 10:00 am

The Bay Area UASI Management Team provides an overview of the risk management process for the grant year; the annual approach to the Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR); the California Common Operating Picture (Cal COP) for Threat Awareness; as well as Protected Critical Infrastructure Information (PCII) certification requirements.

2. Asset Updates and Special Event Data Collection January 26, 2022 – April 15, 2022

Subject matter experts enter data on special events and review and update asset data based, as needed, in Cal COP. The NCRIC reviews and validates the information. In preparation, Haystax will offer a training for Bay Area Cal COP users, by hub, between February 7 - 11 (TBC).

3. THIRA Scenario and Capability Target Review and Development January - March

SMEs will review and provide input on current THIRA scenarios and standardized capability targets. New capability targets will be developed to measure National Priority Area projects.

4. SPR Update March - June

Complete the SPR for all Core Capabilities (i.e. change in capacity from last year, reasons for gaps, and gap-closing strategies). This process will be completed via worksheets and through input gathered from UASI Regional Work Groups and focused meetings with SMEs.

B. FY22 Hub Funding Formula (Action)

Background:

The Bay Area UASI uses Department of Homeland Security's (DHS) Metropolitan Statistical Area (MSA) risk formula to guide the portioning of grant dollars among the Bay Area four hubs using risk criteria. We have used the following hub funding formula for the past ten years:

Population risk (49%) * Asset risk (29%) * Economic risk (22%)

Haystax Technology calculates these risk percentages using the following inputs:

- Population risk = census, density, and commuter data;
- Asset risk = threat, vulnerability, and consequence data from the Bay Area UASI asset catalog in Cal COP; and
- Economic risk = Gross Domestic Product (GDP) by Metropolitan Statistical Area (MSA) and industry data from the U.S. Bureau of Economic Analysis (BEA).

Haystax combines the three weighted risk elements (population, asset, and economic) to determine each hub's overall percentage of risk in the region. Economic data is refreshed every three years, population data is refreshed every five years, and asset data is refreshed yearly.

Discussion:

The population risk data was updated with the 2015-2019 American Community Survey (ACS) 5-Year Data. Asset risk distribution percentages changed minimally, given that our asset database is analytically robust from prior year data clean ups. The economic risk data was updated with the most recent 2020 BEA GDP data by county.

The FY22 hub allocation risk percentages changed minimally from last year. The table below provides the FY22 hub risk allocation percentage results as compared to FY21. The Management Team will be happy to meet and review the hub funding formula process and updates.

Please note that the Management Team's current funding recommendations for the sustainment projects assumes that our FY22 grant will be the same as last year, with the State retaining the same percentage of the grant as last year (i.e. 17.5%).

The Management Team will provide final funding recommendations once DHS announces the FY22 grant award amount, likely at the June Approval Authority meeting. At that time, the Approval Authority will also review/approve all hub projects recommended by hub voting members.








An ongoing opportunity for the whole community partners to coordinate regionally on training and exercise opportunities.





The Bay Area UASI hosted the 2021 Bay Area Pubic Safety Preparedness Summit, a capstone series of exercises and training events, that brought together multiple public safety disciplines, private sector partners, and non-profit community-based organizations in building a more resilient Bay Area.

Golden Eagle Exercise

On November 3rd, 2021, the one-day full-scale / functional Golden Eagle Exercise focused on critical transportation operations and distribution of life sustaining commodities following a 7.0+ earthquake on the Hayward Fault. Participants were confronted with cascading impacts including major damage and disruptions to infrastructure, power, roads, voice communications, and data systems. It exercised the core capabilities of Critical Transportation, Operational Coordination, Situational Assessment, Public Information and Warning, Operational Communications, Community Resilience, and Logistics and Supply Chain Management at local, state, and federal levels.



The following information is being provided to give an overview of the fusion center's activities from January 1 to December 31, 2021.

TERRORISM LIAISON OFFICER OUTREACH PROGRAM - (TLOOP)

<u>Duties:</u> Provide outreach and training to regional partners; review all submitted Suspicious Activities Reports (SAR); follow up on SARs and threats to public safety that require additional information collection and dissemination.



INFORMATION TECHNOLOGY—CYBER

Personnel assigned: Three (3)


<u>Duties:</u> Cyber team members improve regional resilience by sharing sector-specific cyber threat intelligence to public and private sector partners. The team provides support during cyber incidents that includes coordinating physical response and law enforcement involvement. NCRIC Cyber team members are all GIAC-certified professionals.

<u>Activities:</u> In 2021 the Cyber Team increased its briefing schedule to meet demand for real-time intelligence, tailoring weekly content to law enforcement and executive audiences alike. The Cyber Team delivered key cyber incident support during 12 active ransomware attacks or network intrusions in the region, building cases for federal partners and sharing information with stakeholders so that other potential victims could protect themselves.



DIGITAL FORENSIC EVIDENCE LABORATORY

The NCRIC continues to support the Digital Forensic Evidence Lab (DFEL), which reviews data stored on computers and other portable electronic devices. This work assists in efforts to arrest and convict those engaging in criminal acts.




STRATEGY, INFRASTRUCTURE, AND ANALYSIS (SIA) UNIT

Personnel assigned: Four (4)

<u>Duties:</u> The SIA is the NCRIC lead for Critical Infrastructure and Key Resources (CIKR), vulnerability and threat assessments, national data calls for special events and CIKR, special/large-scale event support, and strategic intelligence products and research. The SIA provides support for events based on the potential risk of criminal activity, provides real-time information sharing, and in-depth strategic analysis of regional threats.

<u>Activities:</u> In 2021, in addition to coordinating Real-time Open-Source Analysis (ROSA) of threats to public safety, SIA maintained a COVID-19 dashboard for the NCRIC AOR and assessed vulnerabilities of CIKR. SIA wrote intelligence products on caravan robberies, transnational crime organizations, threat assessments in LGBTQ communities and faith-based organizations and a region-wide threat assessment in collaboration with the State Threat Assessment Center (STAC) and other California fusion centers.


PRIVATE SECTOR OUTREACH

Personnel assigned: One (1)

<u>Duties:</u> Develop/facilitate participation by owners and operators to protect critical infrastructure; provide vetted members with highly valued, sensitive information and intelligence; enhance private sector engagement capabilities.

Activities: During 2021, the team temporarily adapted its private sector engagement efforts to the Covid-19 environment which included a modified outreach strategy, along with webinar-based training and information sharing opportunities for its members. The team partnered closely with the FBI InfraGard Program to increase participation by the private sector in this modified strategy. Despite these temporary program changes the team added its largest number of new members in a single year.




ANALYTICAL SUPPORT (NCRIC-TAG, Priority Crimes, CSU)

Personnel assigned: Ten (10)

<u>Duties:</u> Intake, vet, analyze, and share tips, leads, suspicious activity reports, information, and intelligence on foreign and domestic terrorism, criminal activity or threats to life; regularly collaborate and coordinate with federal, state, local, tribal, and territorial public safety partners, other fusion centers, private sector, faith-based community, and other security partners in our region and nationally to enhance threat information and mitigate risks; provide analytical support for requests for information; develop intelligence products, briefings, threat assessments, or strategic communications regarding regional criminal and terrorism activity trends and patterns; provide investigative and real-time event support; and the Gun-Related Intelligence Program in Santa Clara County.

Activities: In 2021 there was a 20% decrease in Suspicious Activity Reports (SARs), which were de-conflicted and vetted to determine a criminal and/or a terrorism nexus. This decrease can be attributed to the reduction in law enforcement personnel across the State of California due to funding decreases in law enforcement agencies and COVID 19 limitations. There was nearly a 31% increase in case support requests, in which analysts often provide in-depth data-driven analytical products and/or courtroom testimony. Intelligence background package requests remained static during 2021.



TRAINING FOR CALENDAR YEAR 2021

In 2021, due to the on-going Covid-19 pandemic, the fusion center adapted to the public health threat environment by using a virtual technological platform to conduct online training classes. These classes related to homeland security, narcotics enforcement, law enforcement officer safety and investigative techniques. Approximately 113 classes were conducted and 6,069 students from allied agencies and organizations attended the 1,246 hours of instruction.

REGIONAL INFORMATION SHARING PROJECT

<u>Duties:</u> Aggregate standalone data beyond jurisdictional boundaries, from discrete sources into unified interfaces, allowing officers and analysts to more rapidly and accurately identify subjects of investigation.

<u>Activities:</u> The NCRIC Chairs the working group which directs funding allocated for the Law Enforcement Regional Information Sharing project, and the present primary task is to reduce reliance upon UASI funds. Significant progress was made in 2021 toward independent financial sustainment. FY22 will represent the first significant reduction in reliance on UASI funds with a 50% decrease, followed by another 50% decrease planned in FY23.

Stakeholders and project managers continue to advance capabilities and mature the underlying technology platforms, including:


- Evaluation and/or migration to appropriate cloud-hosting providers; improving stability and reliability while facilitating further sharing
- Reincorporation of disconnected data sets
- Improved connectivity with Jail Management Systems
- Transition to lower-cost service providers
- Plan cost-sharing models to distribute financial sustainment among participants

INITIATIVES AND PROJECTS

The NCRIC/NCHIDTA participated in and/or chaired several national and local initiatives and projects in 2021 including:

National Network of Fusion Centers Tradecraft Task Team: the NCRIC, with counterparts in the National Network of Fusion Centers (NNFC), is developing a national professional development framework for intelligence analysts. This framework will enhance analytical standards and cultivate subject matter experts (SMEs) within the NNFC. Goals for this project include more impactful local analysis at a grander geographic scale, faster sharing of precise insight for actionable intelligence, and a collectively clearer national threat picture.

National Emerging Threat Dashboard: the NCRIC leadership is developing and implementing the Emerging Threat Dashboard to share immediate alert and warning notifications, improve real-time joint intelligence production, and improve strategic planning. This dashboard will be utilized by the NCRIC, other Fusion centers, HIDTAs/ISCs, RISS Watch Centers, Major City and County Intelligence Commanders, and State and Federal intelligence partners to continue progress for a Regional Integration and Coordination concept.

Background

Pursuant to the FY 2020 NOFO, one project in the Soft Target/Crowded Places investment must be to support enhancing election security. [pg 6; HSGP NOFO]. The National Priority project in the Soft Targets/Crowded Places investment area supporting Election Security was approved as Identity Access Management.

Discussion

Due to COVID restrictions and delays in FEMA funding release, the FY20 Identity Access Management project's Gaps and Needs analysis will take longer than expected and requires a rescoping of the project. In order to execute project activities within the performance period, the Management Team has identified national best practices in order to re-scope project deliverables.

Listed in Table One below are the original and revised project descriptions. The Management Team is seeking approval to amend the project scope for the FY20 Soft Target Project.

Each one of the five national priority projects are to be funded at either 5% (protection of soft target/crowded places, enhancing info/intelligence sharing, and emergent threats) or 7.5% (enhancing cybersecurity and combating domestic violent extremism), totaling 30% of the total grant award.

Please note that the Management Team's current funding recommendations for the National Priority projects assumes that our FY22 grant will be the same as last year, with the State retaining the same percentage of the grant as last year (i.e. 17.5%).

Discussion

In order to satisfy FEMA's National Priority Project requirements, the Management Team collaborated with UASI regional workgroup members and SMEs to establish a list of National Priority Projects as depicted in Table 2 below. The projects align to the region's THIRA/SPR and meets the criteria for effectiveness, which will be competitively reviewed by DHS/FEMA. Funding for each National Priority is targeted between \$1,550,625 (5%) and \$2,325,938 (7.5%) of the award.

Listed in Table 2 and Table 3 below are the five national priorities, the proposed associated projects, and recommended funding amounts for a total of \$9,303,750 – 30% of the grant award.
