Background:


The sub-recipient performance period for the FY 2010 UASI grant is October 21, 2010 – September 30, 2012, with final claim for reimbursement by no later than November 30, 2012. Extensions up to November 30, 2012 are being reviewed and granted in highly justified cases. This update is a follow-up to last month's report. Actual spending has increased from 25% to 28%. Based on reports from the jurisdictions, the table above has been expanded to show the finished projects that await billing. Combining total spending and pending claims, the completed projects now account for 30% of the total budget.

Obligated funds represent projects that are on track to their completion at verified deliverable dates. These funds also include positions that are confirmed to be filled by the jurisdictions. There are no funds identified for reallocation at this point.

Some project extension requests have been approved and soon will be reflected on amended MOUs. All projects and spending will be completed by the end of the grant.
