#### II. Project Goal

Funding is required beginning in January 2014 to continue maintenance and sustainment of the BayLoop network by continuing extended warranty/maintenance services and Network Operations Center (NOC) services.

#### IV. Project Description

BayLoop is a regional Microwave Radio System that benefits members of all four hubs and can potentially provide benefits to the entire UASI footprint. BayLoop circles the Bay Area connecting 18 radio sites located in eight counties. BayLoop will provide the wide area connectivity to support regional Information Sharing, Broadband Data and Voice Systems throughout the Bay Area Region and beyond, and will serve as a key element of the BayWEB/FirstNet backhaul network.

BayLoop was funded \$4,235,710.00 (7.3%) from the UASI 06, 07 and 08 Grants to complete what was started with San Francisco UASI 05 funding. However, this funding did not cover extended warranty/maintenance services and NOC services. BayRICS Authority requested and received \$265,000 in Maintenance and Sustainment funding from UASI 12, however, this funding only covered network maintenance and monitoring costs for 12 months, through December 2013, with an option to extend the agreement for one additional 12-month period.

Additional funding of \$240,000 is required to extend these services through December 2014.
