# II. REGIONAL TRAINING & EXERCISES PROGRAM - Dennis Houghtelling

# A. PROJECT UPDATE

1. Discussion of the Training and Exercise vetting session scheduled for February 21, 2013.

Commander Houghtelling informed the workgroup the next vetting session for course proposals will occur on February 21, 2013, and there are currently 38 course proposals submitted. The website will be available to submit proposals until a week prior to the next meeting.

2. Discussion regarding class attendance (last minute cancelations)

Commander Houghtelling informed the workgroup students have been cancelling their attendance within days of the course starting and asked the workgroup to let their staff know to unregister themselves as soon as they know they will be unable to attend.

## **B. ANNUAL REPORT-Completed**

Commander Houghtelling told the workgroup the first Annual Report was completed and will be given to the advisory group followed by the approval authority for final review.

B. RCPGP – An additional \$230,000 is being added to this grant to spend on Regional Catastrophic Preparedness courses. The time frame given is very short so we will have to work fast to find vendors and sites to conduct courses. Please let me know if you are interested in hosting a class.

Julie Linney informed the workgroup the RCPGP grant obtained an additional \$230,000 for courses. Julie said she will be adding PIO courses in February. Julie also said CSTI will not be able to be utilized as a vendor until a contract is reestablished.

C. Grant Year 2010 – There was quite a bit of money returned to UASI from jurisdictions that were unable to spend it. In order for us to make sure that jurisdictions spend their money in a timely manner, we will be doing more monitoring of projects. You can expect a call from me or other Project Managers asking the status of your projects on a frequent basis. Remember, 2012 has a 2-year performance period so we want to find out sooner rather than later if a project will not be able to be completed.

Julie Linney informed the workgroup that Grant Year 2010 is closing soon and everything must be done by the end of February, reimbursements must be in by the end of March and the grant closes in April. If an extension is approved, the extension would go until July. Julie also informed the workgroup they received a lot of money back from jurisdictions that were unable to spend it and as a result, there will be more outreach and monitoring during the 2011 & 2012 grant cycles.

D. 2013 Project Proposals – All 2013 Project Proposals will be heard in their perspective Hubs this month. If you have a project, we strongly suggest that you attend this meeting to give an overview of that project. All projects will be ranked and then moved to the Advisory Group for recommendation to the Approval Authority. The Approval Authority will then consider project approvals at their March meeting.

Julie Linney informed the workgroup the South Bay Hub meeting was held and they prioritized and ranked their projects. There will be three more meetings in the future for the North, West and East Bay Hubs.
